- 1. **Partner in Pet Food Hungária Korlátolt Felelősségű Társaság** (registered seat: H-2040 Budaörs, Puskás Tivadar utca 14.; company registration No: 13-09-090774; e-mail: info@ppfeurope.com; telephone: +36 1 801 02 03) ("**Company**") is using cookies in certain areas of http://www.ppfeurope.com/. Cookies are files that store information on the users' web browser. This Cookie Policy ("**Policy**") provides information on the use of cookies.
- 2. _gid	Statistical cookie – enabled by default, and the user can enable or disable it at any time A cookie used by Google (third party cookie).	It is similar to the _ga cookie. It is used to distinguish users anonymously, allowing Google Analytics to measure visitors' usage habits on the website.	24 hours
Youtube cookies	Convenience cookie – enabled by default, and the user can enable or disable it at any time A cookie used by Google (third party cookie).	We embed videos from our own official Youtube channel in the site in the so-called privacy-enhanced mode. These embedded videos do not appear, unless you accept the convenience cookies. In this case, Youtube leaves some cookies on the user's device which the service provider cannot control. These cookies do not allow personal identification of the user.
